Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI LODR Regulations”), we hereby inform that the Board of Directors of the Company, at its meeting held today i.e. **Saturday, January 24, 2026**, inter alia, considered and approved/took note of the following matters:

1. The Board considered and approved the change in vendor / Original Equipment Manufacturer (OEM) for procurement of the simulator, as earlier disclosed in the Red Herring Prospectus, owing to revision in commercial terms by the originally identified vendor.

The Board noted that the change in vendor shall be affected without any increase in the overall project cost and shall remain within the price parameters approved earlier, and does not result in any deviation from the objects of the issue.
